

Pre-startup inspections begun at Japan's Ikata-3; Unit 1 to be closed. Japanese district court dismisses suit to halt Sendai operation. Coolant channel leak idles India's Kakrapar-1. Eskom submits applications for two new power reactor sites in South Africa. Key equipment now in place at Flamanville-3. Steam generator dropped during removal from Paluel-2. France's CEA, EDF, Areva join to create nuclear platform. Power reactors planned for Jordan to start up in 2024–2025.
