

What Lies Ahead

Like most people, every once in a while I will say something really stupid. Case in point: Several years ago, I worried out loud about what the magazine could possibly cover once all the current nuclear power plant decommissionings were finished and once Fernald and Rocky Flats were cleaned up and closed. As we wrap up the year 2010 and look ahead into 2011, the biggest issue on the horizon remains Yucca Mountain. Are reports of its death premature, or, to paraphrase Mark Twain, greatly exaggerated? Will U.S. Nuclear Regulatory Commission decisions and/or court rulings breathe life back into the proposed high-level waste/spent fuel repository? In the meantime, what will the President's Blue Ribbon Panel on America's Nuclear Future recommend as a path forward? This is one issue that may achieve clarification in 2011.

The \$6 billion in stimulus money that was poured into U.S. Department of Energy cleanup projects must be spent by September 30, 2011 (the end of the 2011 fiscal year), so for the first nine months of the year, there will be a big push at the government cleanup sites to get the projects completed. It will be good to see the final results of this extra funding provided by the American Recovery and Reinvestment Act as 2011 wraps up.

As reported in the "Headlines" section of this issue (see page 10), the NRC approved the transfer of the license for the Zion nuclear power plant from Exelon to ZionSolutions, a subsidiary of EnergySolutions. This means there is more commercial nuclear power plant decommissioning work ahead. With a cost estimate of \$1 billion, this commercial decom-
